## PUPPY SALE CONTRACT FOR

This is an important document. You should not buy the dog/bitch or sign this Contract unless you intend to be bound by its' terms and conditions.

Between Manderian Border Collies (hereinafter 'breeder, breeders, us, we') and Purchaser (hereinafter 'you, your')

1. This dog/bitch has been bred with care & raised in a busy household enviroment and is used to the doorbell, Hoover, telephone, people laughing, dogs barking and other everyday noises. He/she has been handled and socialised since the moment of birth.
2. This dog/bitch is believed to be in good health and has, within the last 48 hours, been health checked by our Vet. You have 72 hours to, at your own cost, have your Vet health check this dog/bitch and make arrangements to begin the appropriate vaccination programme. If during these 72 hours anything is found that you are not happy with, you will return the dog/bitch to the breeder and receive a refund of the purchase price of £XXX.XX (insert value in words here pounds sterling) less any non-refundable deposit providing that:
  - you specifically confirm that we will not be held responsible for any distress caused by the return of the dog/bitch.
  - you are solely liable for any costs associated with the return of the dog/bitch to us
  - it is returned to us within 72 hours of being purchased
  - it is in the same state of health as it was when purchased
  - it is not damaged, or been operated on, in any way
  - it has not been injected with or otherwise administered any vaccination or drugs of any sort.
  - you provide, free of charge, a written statement from your vet setting out the problem, and including the name and identifying microchip number.
3. Before purchase you should consider the dog/bitch as a living thing which will become a much loved member of the family in a very short time. Every effort has been made to ensure that this dog/bitch is healthy in body and mind, and is sold subject to it being understood that as a living creature it is impossible to predict how it will continue to develop, especially as regards behaviour over which you will have the principal influence.
4. You understand and accept that two endorsements have been placed upon the Kennel Club Registration of <Registered Name of Dog> in that: Export Pedigree Not Allowed and Progeny Not Eligible for Registration. Further, you understand that these restrictions will only be lifted by the breeder,

address as given above, who will lift the Export Pedigree Not Allowed restriction only by your written application to them and production of other satisfactory documentary evidence, explaining the reasons why an Export Pedigree is required, that may be required by the breeder. The Progeny Not Eligible for Registration restriction will only be lifted on the following conditions:

- production of satisfactory written evidence from the BVA that <Registered Name of Dog> has been hip scored in accordance with the KC/BVA Scheme and that the total hip score for this dog/bitch is no greater than 10 points above the current breed average
- holds a current (i.e. no older than 12 months) clear ('Unaffected' by CEA, CPRA, PRA, PLL, & PHPV) Eye Test Certificate
- that <Registered Name of Dog> is considered by the breeder, or nominated representative, to be a good example of the breed
- that <Registered Name of Dog> is of sound temperament and
- that <Registered Name of Dog> is not suffering from, or being treated for, any disease or condition that may affect or be inherited by his/her offspring.

These conditions are in place to help protect this dog/bitch, the Border Collie breed and the breeders.

5. You understand and agree that if at any point during the lifetime of <Registered Name of Dog> you are no longer able or willing to keep and maintain him/her, you will return him/her to the breeder, along with all registration documentation (signed appropriately to return ownership to the breeders) all vaccination and veterinary treatment records including all health testing results and certificates, and that YOU WILL NOT abandon, sell/give away or otherwise pass this dog/bitch on to any other person, rescue centre, party or organisation.
  - If this clause is breached, and we are forced to locate and recover the dog/bitch, you acknowledge and accept that you will be wholly liable for all costs and associated costs of recovery, including legal fees and overseas recovery if the dog/bitch is found to be exported; whether or not that you knew the dog/bitch was exported.
  - If this dog/bitch is freely returned to us, you may expect a refund of the purchase price, less any non-refundable deposit, feeding costs, veterinary charges and any other associated charges/fees and advertising costs if/when the dog/bitch is sold by the breeder to other suitable person(s). We bred this dog/bitch are committed to his/her welfare and well-being.
6. You agree and confirm that you will give <Registered Name of Dog> every care and attention according to his/her needs and that you will have:

- Him/her vaccinated annually by a Registered Vet or Vaccination Clinic, or follow a specific vaccination program as prescribed by a BVA registered Vet, wormed at least every six months and have any other treatments that may be recommended by a Vet for the health and well-being of this dog/bitch.
  - You further understand that if there is a failure to keep any part of this contract, or if the dog/bitch is neglected, maltreated, or is failing to receive adequate medical care, you will immediately surrender said dog/bitch to the breeder unconditionally and without financial restitution or compensation, along with all registration documentation (signed appropriately to return ownership to the breeders) all vaccination and veterinary treatment records including all health testing results and certificates.
7. You agree to report all changes of address and telephone number to the breeder throughout the lifetime of this dog/bitch. The breeder will make all reasonable efforts to advise you of any changes of address and/or telephone numbers of the breeders.
8. This dog/bitch has been microchipped to aid identification and its return should it be lost or stolen.
9. This dog/bitch will have been wormed a minimum of 3 times before leaving the breeder. Further information on dates of worming and of any worms seen/produced will be detailed on a separate sheet along with detail of any veterinary treatment received by this dog/bitch.
10. The parents of this dog/bitch have been:
- Eye tested
  - Hip scored
  - BAER Hearing tested. Both are hearing normal.
  - DNA Tested for CEA. Both are Normal (i.e. they do not carry the gene) Therefore this dog/bitch is 'Normal by parentage' for CEA.
  - DNA Tested for (N)CL (bp 619 C to T mutation in exon 4 of the canine *Cln5* gene). Both are Normal. Therefore this dog/bitch is 'Normal by parentage' (bp 619 C to T mutation in exon 4 of the canine *Cln5* gene).
11. This dog/bitch has passed an Ophthalmic Eye examination and may have been BAER Hearing Tested. Any variance from a 'Normal' result will be detailed on individual puppy records. Please see copies of relevant certificates/forms for more detail.

13. You understand that you can approach us for help, advice and information at any time during the lifetime of this dog/bitch and that it, wherever possible, will be freely given.
14. We are interested in everything that happens in the life of this dog/bitch, good or otherwise. You agree to keep in touch with the breeders with an update at least 4 times every year.
